



# Al Resalah American International School Anti-Bullying Policy 2025-2026

#### **Purpose**

Al Resalah American International School is committed to providing a safe, nurturing, and inclusive environment for all students from Pre-KG to Grade 12. This anti-bullying policy aims to prevent bullying in all its forms, protect students, and ensure compliance with UAE Wadeema Law (Child Protection).

# **Definition of Bullying**

Bullying is defined as any repeated, intentional behavior by a student or group of students that causes physical, emotional, or psychological harm to another student. Bullying can be verbal, physical, social, or cyber in nature and includes, but is not limited to:

Verbal Bullying: Teasing, name-calling, inappropriate sexual comments, taunting, threatening to cause harm.

Physical Bullying: Hitting, kicking, pinching, spitting, tripping, pushing, taking or breaking someone's things, making mean or rude hand gestures.

Social Bullying: Spreading rumors, embarrassing someone in public, excluding someone purposefully from activities or groups.

Cyberbullying: Using digital devices to harm another individual, including sending threatening messages, spreading rumors online, posting harmful content, or impersonating someone with the intent to harm.

# **Policy Statement**

Al Resalah American International School has a zero-tolerance stance on bullying. All forms of bullying are unacceptable, and every student has the right to feel safe and respected. This policy ensures that any bullying behavior will be addressed promptly and effectively.

# **Reporting and Response**

# Reporting Bullying

Students: Encouraged to report bullying incidents to teachers, school counselors, or any trusted staff member.

Parents: Can report bullying incidents to the school administration or directly to the child's teacher.

Staff: Must report observed or reported incidents of bullying to the school administration.

# Response to Bullying

Investigation: The school administration will promptly investigate all reported bullying incidents.

Intervention: Appropriate interventions will be designed to stop the bullying and support the victim.

Interventions may include counseling, mediation, and disciplinary actions for the perpetrator.

Follow-up: Continuous monitoring to ensure the bullying has stopped and that the victim feels safe. Additional support will be provided as needed.

#### **Prevention Strategies**

Education: Implement comprehensive programs to educate students, staff, and parents about bullying, its effects, and prevention strategies.

Environment: Create a positive school environment that promotes respect, diversity, and inclusion through school-wide activities, classroom discussions, and the school curriculum.

Training: Provide regular training for staff on recognizing, preventing, and responding to bullying.

# **Compliance with UAE Wadeema Law (Child Protection)**

In accordance with UAE Wadeema Law (Federal Law No. 3 of 2016 Concerning Child Rights), our school is committed to safeguarding children's rights to protection from abuse and neglect. This includes:

Confidentiality: Maintaining the confidentiality of the reporting and investigation process to protect the privacy of all parties involved.

Support: Offering psychological support and counseling services to victims of bullying.

Legal Compliance: Reporting serious cases of bullying that constitute child abuse to the appropriate authorities as required by UAE law.

## **Roles and Responsibilities**

School Administration: Ensure the implementation of this policy, oversee investigations, and enforce disciplinary measures.

Teachers and Staff: Foster a safe and supportive environment, intervene in bullying situations, and report incidents.
